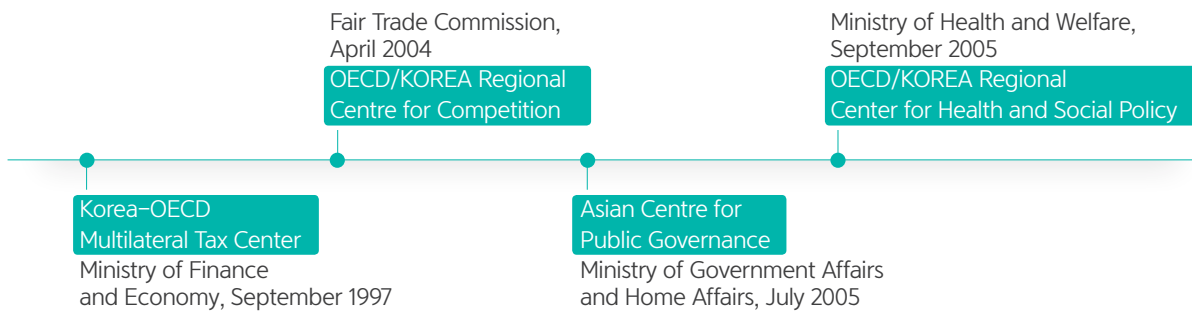




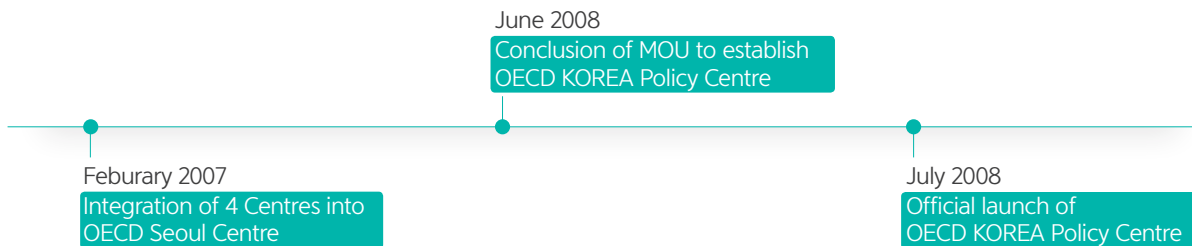

## ❖ Dissemination of better policies & systems

- Shared experience in tax policies and administration with Vanuatu (Ministry of Finance and Economic Management), Mongolia (General Department of Taxation) and Maldives (Maldives Inland Revenue Authority)
- Exchanged law enforcement experience of OECD member countries with competition officials of 33 different jurisdictions in the Asia-Pacific region
- Disseminated advanced experience of OECD member countries on public governance to public officials of the Asia-Pacific countries including Malaysia and Vietnam
- Conducted international training programmes on public pension in the Asia-Pacific region

Recognising the importance and strong influences of the OECD/G20 BEPS Project, the Tax Programme has cooperated with international and regional tax organisations such as OECD, ADB, World Bank and CATA and organised international conferences to promote the BEPS project strengthening the engagement of developing countries. It has been supporting emerging economies in the region to be actively involved in the global dialogue on the international taxation.

The Competition Programme co-hosted workshops/seminars with the International Competition Network (ICN), Malaysia (MyCC), Vietnam (VCCA) and the Supreme Court of Indonesia, as well as with the Competition Law Implementation Program (CLIP).

The Public Governance Programme strengthened the policy network of government officials from the Asia-Pacific countries with the APG Forums and Capacity Building Programmes.

The Health and Social Policy Programme co-organised international conferences with various Korean institutes and supported the international events to strengthen the policy network.

# TAX Programme

## TAX Programme

The Tax Programme (Korea Tax Center, KTC) was established in order to disseminate advanced tax policies and policy experience to partner economies in the Asia-Pacific region in cooperation with the OECD. The main missions of the Tax Programme are to provide opportunities to share tax policies and administrative experience on international taxation such as Transfer Pricing, Tax Treaties and Exchange of Information while carrying out research projects on recent tax trends such as Base Erosion and Profit Shifting.

It also hosts policy forums for tax experts at home and abroad as well as seminars on tax systems for developing countries and conducts cooperative projects with regional tax organisations.



## Key Performance

Since 1997, the Tax Programme has been annually hosting 6 to 7 regular OECD international tax seminars inviting more than 4,000 middle and high ranking tax officials from 50 countries in the Asia-Pacific region. As of today, the number of seminars held by the Tax Programme has reached 130.

OECD tax seminars carried by the Tax Programme have been highly evaluated by the OECD as well as by participants in terms of its awareness and participant-satisfaction. The Tax Programme has been evaluated as one of the best OECD Tax Seminars & Events according to the OECD's Independent Evaluation Service.

The Tax Programme has been trying to enhance understanding of Korea in order to strengthen neighborly relations with tax officials that participate in its seminars. In part of this effort, it has been introducing various kinds of information on economic development, culture, and history of Korea as well as providing study visits to industrial and historical sites for participants.

The Tax Programme has operated the KTC Family website that manages database concerning participants and experts' information and provides opportunities for tax officials and experts in the Asia-Pacific region to exchange information on advanced tax policies and experience.

In 2018, the Programme has conducted 3 bilateral programmes with emerging economies including Vanuatu, Mongolia and Maldives.

### About OECD/G20 BEPS (Base Erosion and Profit Shifting)

Base Erosion and Profit Shifting (BEPS) is a global problem which requires global solutions. BEPS refers to tax planning strategies that exploit gaps and mismatches in tax rules to artificially shift profits to low or no-tax locations where there is little or no economic activity, resulting in little or no overall corporate tax being paid. BEPS is of major significance for developing countries due to their heavy reliance on corporate income tax, particularly from multinational enterprises (MNEs).

In an increasingly interconnected world, national tax laws have not always kept pace with global corporations, fluid movement of capital, and the rise of the digital economy, leaving gaps that can be exploited to generate double non-taxation. This undermines the fairness and integrity of tax systems. The final reports and the toolkits have been developed in the context of the OECD/G20 BEPS Project to equip governments with the domestic and international instruments needed to address this challenge. They will give countries the tools to ensure that profits are taxed where economic activities generating the profits are performed and where value is created, while at the same time give business greater certainty by reducing disputes over the application of international tax rules, and standardising requirements.

As the BEPS project has entered an implementation phase, the OECD has launched the Inclusive Framework, a platform where all the tax jurisdictions can be involved in the process of setting the global agenda on an equal footing. Under the inclusive framework, over 120 countries and jurisdictions are collaborating to implement the BEPS measures and tackle BEPS.

- The Tax Programme will continue working with international and regional organisations such as ADB, World Bank, CATA and PITAA to organise customised conferences based on partner economies' needs supporting emerging economies in the region to catch up with the OECD guideline.
- It will continue to maintain and enhance the network with country representatives by utilising the Knowledge Sharing Platform.

# Competition Programme

## Competition Programme

The function of the Competition Programme is to disseminate OECD member states' competition law and policy to government officials and judges who deal with competition law cases in the Asia-Pacific region.

For this, the Competition Programme holds international competition workshops/seminars, carries out research on competition law enforcement trends, and issues newsletters.



# Key Performance

## ❖ Competition Law Workshop/Seminar

The Competition Programme has been making efforts to promote capacity building on competition law and policy in the region. Since 2004, it has been contributing to the dissemination of best practices of the OECD by hosting 86 workshops/seminars and inviting 2,543 participants.

The Competition Programme holds competition law workshops/seminars, providing opportunities for competition officials in the region to share their experience and knowledge for an effective competition law enforcement. The Programme has been hosting regular workshops in Korea where main competition law issues such as cartels, mergers, and abuse of dominance are discussed since 2004; in-country workshops to ensure an active participation of local officials since 2005; sector specific workshops to focus on competition issues in particular sectors such as ICT, telecommunications, and IP since 2010; seminars for judges to explore competition law theory and cases from 2011; and bilateral seminars for competition authorities in the region to meet the needs of target jurisdictions since 2017.

In 2018, the Programme hosted 5 workshops/seminars including a joint event with the ICN (International Competition Network) to disseminate best practices of the OECD and the ICN, a bilateral seminar in Vietnam that has recently revised its competition law, and a seminar for judges in cooperation with the Supreme Court of Indonesia, inviting 219 participants in total.

# Health and Social Policy Programme

## Health and Social Policy Programme

The Health and Social Policy Programme was established in 2005 in order to support capacity building of health and social policies in the Asia-Pacific region in cooperation with the OECD. The main fields of the Programme include health, social and pension policies. It disseminates OECD's policies, trends, and indexes by hosting international meetings to provide opportunities for experts to share policy experience between countries and providing training courses to introduce Korean policies.

In addition, the Programme translates and distributes the OECD's publications including the "At a Glance" series on Health/Society/Pension on the latest trends. Also, various research projects on health and social policies have been conducted.

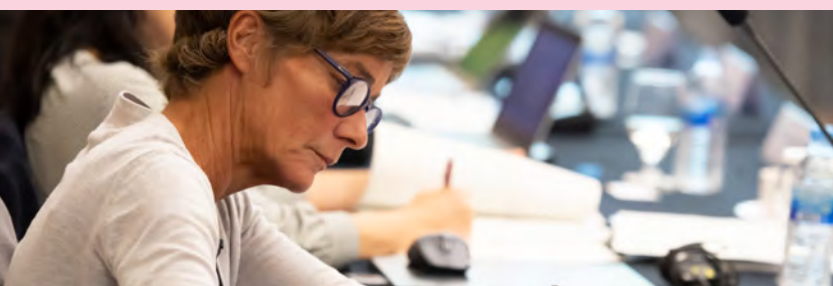

## ❖ International Training Programme

- The Health and Social Policy Programme expanded its international training programmes to cover a wide range of topics such as health and social issues since the launch of the first international training course on social health insurance in 2012. In 2013, two training courses on social health insurance and community based support service for persons with disabilities were held, and the first training course on public pension was conducted in 2014.
